PART I. General Expectations

Wills Elementary agrees to implement the following statutory requirements:

E. The carrying out of other activities, such as those described in section 1118 of the ESEA.

PART II. Description of how [Wills Elementary] will implement the required components of the campus Title I Parent Engagement Plan.

1. Wills Elementary will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
 - To increase parent accessibility and participation, these meetings will be offered in English, Spanish, Burmese and Chin and hosted at different times of the day. Prior to reviewing, discussing and amending the plan, each meeting will offer parents' training on what Title I entails and the importance of parent input.

2. Wills Elementary will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
 - Each spring our goal is to select a parent from each grade level. Provide them training in process of developing our Campus Improvement Plan.
- Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
 - Each spring, all staff are involved in a comprehensive needs Assessment, for the purpose of identifying areas in which improvement is needed. These needs are then addressed in our Campus Improvement Plan.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. Wills Elementary will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- Back to School Night, tabling during registration, parent/teacher conferences, Call Outs, handouts, social media posts, etc.
- Language support will be made available, as needed.

4. Wills Elementary will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's

curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- Grade level parent information meetings and STAAR information meeting.
- Language support will be made available, as needed.

5. Wills Elementary will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible.

These may include, but are not limited to, the following:

- Parent/Teacher conferences, Suggestion box, Regular Parent Empowerment Classes.
- Language support will be made available, as needed.

6. Wills Elementary will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- Sending information home that is also located on the school website and sending copies of reports upon request.

7. Wills Elementary will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following: (list your own examples here):

10. Wills Elementary will, to the extent feasible and appropriate, coordinate and integrate TI parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- Send a letter to incoming parents inviting them to their new campus, have Pre-K kids in music room while Pre-K parents have orientation before school starts.
- Hope/Pat Program information.
- Language support will be made available, as needed.

11. Wills Elementary will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- Providing interpreter and translation services at meetings where a reasonable extent of parents speak a language other than English, provide services upon request, use the language line, etc.

PART III. Discretionary Components of the Wills Elementary Title I Parent Engagement Plan

Wills Elementary may provide discretionary activities that build parents' capacity for engagement in Title I schools and the school system to support their children's academic achievement; these may include, but are not limited to, the following:
